Each of the undersigned(s) further agree that in the event any claim or action is initiated against the Organizer(s), whether or not named herein, which claim or action in any manner relates to the Facility or any event held there or at remote locations, the undersigned(s) agree(s) to fully indemnify and hold harmless the Organizer(s) from any such claim or action.

Each of the undersigned(s), being duly aware of the risks and hazards inherent upon entering upon said Facility and/or in participating in any event held at the Facility or at remote locations, hereby elect(s) voluntarily to enter the Facility or remote location, knowing the present condition and knowing that said condition may become more hazardous during that time that each of the undersigned is at, on or near the Facility or remote location.
